1. **Apologies for Absence** – Received and accepted from Mr A Lewis & Miss C Morris
2. **Minutes** of Meeting held on 23rd March 2020 were read and approved as a correct record..
3. **Matters Arising from last meeting** – There were no matters arising from the previous meeting.
4. **Appointment of Chair and Vice Chair** – It was proposed that due to the current social and environmental conditions in the country that the current Chair and Vice-Chair should continue in post for the 2020-21 year.

5. **Planning Issues**
 - a. **Hendy Wind Farm** – The clerk provided members an update in respect to papers surrounding the applicants submission in respect to meeting the Archaeology survey conditions of the approved application.

 - a. **COVID – 19** – Members noted the number of updates that the clerk had circulated from both Powys CC and Powys Health Board in respect of the current pandemic.
