Minutes of the Meeting of the Council held in Aberedw Church Hall at 7pm on Tuesday 30th August 2022.

- 1. Apologies: Cllr Mr P Hope,
- 2. Present Councillors Mr R Samuel (Chair), Mr A Lewis, Mr G Jones (Acting as Clerk), Mrs D Kenely & Mrs D Powell.
- 3. Minutes of Meeting held on 13th June 2022 were approved as a correct record.
- 4. Matters Arising from last meeting, if not on the agenda
- 5. Planning Issues
 - a. The clerk provided members with a brief introduction to BUTE energy plans to develop an energy park on Radnor Forest consisting of 36 Wind Turbines (220m to the Tip, 100 Megawatt of Solar Panels (Approximately 200 Hectares) and a Battery storage facility. He also informed members that the initial plan involves a temporary bridge across the River Wye in the Aberedw Area.
 - **Members** thanked the clerk for the update and asked him to keep them informed of any further information he receives.
 - b. The clerk informed members that the planning application to make alterations to an adjoining building at Edw Cottage had received planning consent, it was noted that the decision had taken 10 months and he has asked for an explanation of why it has taken so long.

6. Other Correspondence & Meetings attended

The Clerk informed members that he had received the following documentation:

- a. Various planning List Notifications
- **b.** A power point presentation on the Council's Planning Services, planned review of the LDP to come into force in 2025/26 and the current Phosphates issue. (Circulated earlier in the evening)
- c. The Welsh Government's Good Councillors Guide (Circulated earlier this evening)
- **d.** A power point presentation on the levelling up UK shared prosperity fund (Circulated earlier this evening)
- e. Correspondence between the Community Council and the County Council in regard to the responsibility for the church dating back to 1980. In the most recent correspondence dated 20th February 2012 the County Council has stated clearly that unless it is linked to a road widening scheme that the responsibility rests with the Church.

- **f.** A letter received from the Red Dragon Festival of Endurance confirming their intention to hold the event this year on the weekend of the 30th September to the 2nd of October.
- g. A copy of an e-mail sent to Father Paul from the Church Authorities in which they state they were willing to transfer the ownership of the Church Hall on a long-term lease to a local community group and potentially the Community Council.

Resolved – Following a discussion it was agreed that if this was to progress that the building should be transferred to the Aberedw Sports and Community Group or similar charitable group and that the Community Council would be willing to have one member on the board of trustees of any charity established for this purpose and that the established charity should be a CIO.

7. Finance Issues

- a. Members received and approved the annual return and the accounts for the year ending 31st March 2022.
 - The clerk apologised that there had been a delay, caused by himself in the completion of the documentation, which would most likely result in a qualified audit report.
 - The return showed that at the end of March 2022 the Council had reserves amounting to £3,702.49 of which £2,500.00 was in the specific reserve for election expenses.
- b. The Clerked informed member that the balance in the accounts currently stands at £4,779.49 but there were accounts due for the cost of the elections in May and last year external audit.
- c. It was noted that no payments had been made since the last meeting, although the clerk is due to be re-imbursed for the annual cost of the Web Site.

8. Any Other Business

- **a.** Members were pleased to see that after 50 years a sign has been placed at the entrance to Edw Crescent.
- b. The issue of dog mess in the village was raised again. The Clerk was asked to investigate the cost of the supply of dog bags.
