Minutes of the Meeting of the Council held in Aberedw Church Hall at 7pm on Monday 13th June 2022.

1. **Apologies:-** Cllr Mrs D Kenely,
2. **Present –** Councillors Mr R Samuel (Chair), Mr P Hope, Mr A Lewis, Mr G Jones (Acting as Clerk) & Mrs D Powell.
3. **Mr C Woods** – It was with sadness that the members noted the passing of Mr Christopher “Chippy” Woods on Saturday the 11th June after a long illness. The Clerk was asked to send a sympathy card to his widow Mrs June Woods and her family. The members sat in silence in memory of Chippy.
4. **Minutes of Meeting held on 16th May 2022** were received and accepted as a correct record.
5. **Matters Arising from last meeting**
 - a. Members noted that the issues raised under AOB at the last meeting were still outstanding, the clerk confirmed that he is hoping to arrange a meeting with Mr Ellis from Powys to discuss the highway related issue.
 - b. The clerk also informed members that as the village does not currently have any speed restrictions in place, that the proposed changes to speed limits in urban areas in Wales from April 23 are not expected to apply to the village.
 - c. The clerk is currently investigating the cost of signage in relation to dog fouling and the cost of providing a dog bin and dog poo bags.
6. **Planning Issues** – No new planning applications have been submitted in respect of the Aberedw Community Council Area
7. **Other Correspondence & Meetings attended** – The clerk updated members on the correspondence that he had received since the last meeting in May:-
 - a. Various planning List Notifications – None of which affected the Aberedw Community Council Area.
 - b. Flyer re Powys supported lodgings for young adults leaving care.
 - c. Updates from One Voice Wales, Powys Community Health Council, Welsh Government
 - d. **Appointment of a Town/Community Councillor for the Radnorshire Area** to the Powys County Council Standards Community Sub-Committee. It was agreed that the vote should go to Mr Nigel Dodman.
8. **Finance Issues**
 - a. The members received and approved the final accounts for the year ending 31st March 2022 which showed a total spend in year of £1,354, with the only income being the £900 precept resulting in a decrease in reserves in year of £454 to £3,703 of which £2,500 is in a specific reserve in relation to the elections.
 - b. Members approved the clerk to complete the paperwork and to publish the accounts on the 3 notice boards following review by the Council’s Internal Auditor.
 - c. The clerk informed members that Cllr Kenely had suggested that if the Community Council were considering making donations to any groups and charities that she felt it should focus any such donations to groups that were currently dealing with poverty related issues such as a Food Bank, the Hive in Llandrindod and the Builth Community

Support. **Members felt we should focus our support on families in our specific area and to consider any applications towards the end of the financial year.**
